

**Summary Statement:**

Please open the City Council meeting at this time to hold a Public Hearing on the 2020 tax year proposed property tax rate. Because the proposed rate will exceed the no-new revenue tax rate, or the voter-approval tax rate, (whichever is lower), this public hearing must be held on the proposed tax rate. The proposed tax rate is a total rate of **\$0.395218** per \$100 valuation. Of this total rate, **\$0.080988** will be the 2020 debt tax rate and **\$0.31423** will be for the operations and maintenance of the General Fund of the City of Lampasas. **Per State Requirements, the governing body must announce at this hearing: The proposed date, time, and place of the meeting at which the City Council will vote on the tax rate. The meeting for the City Council to adopt the proposed tax rate will be Monday, September 14, 2020 at 6:00 pm at the City Council Chambers located at 302 East Third Street, Lampasas, Texas.**
